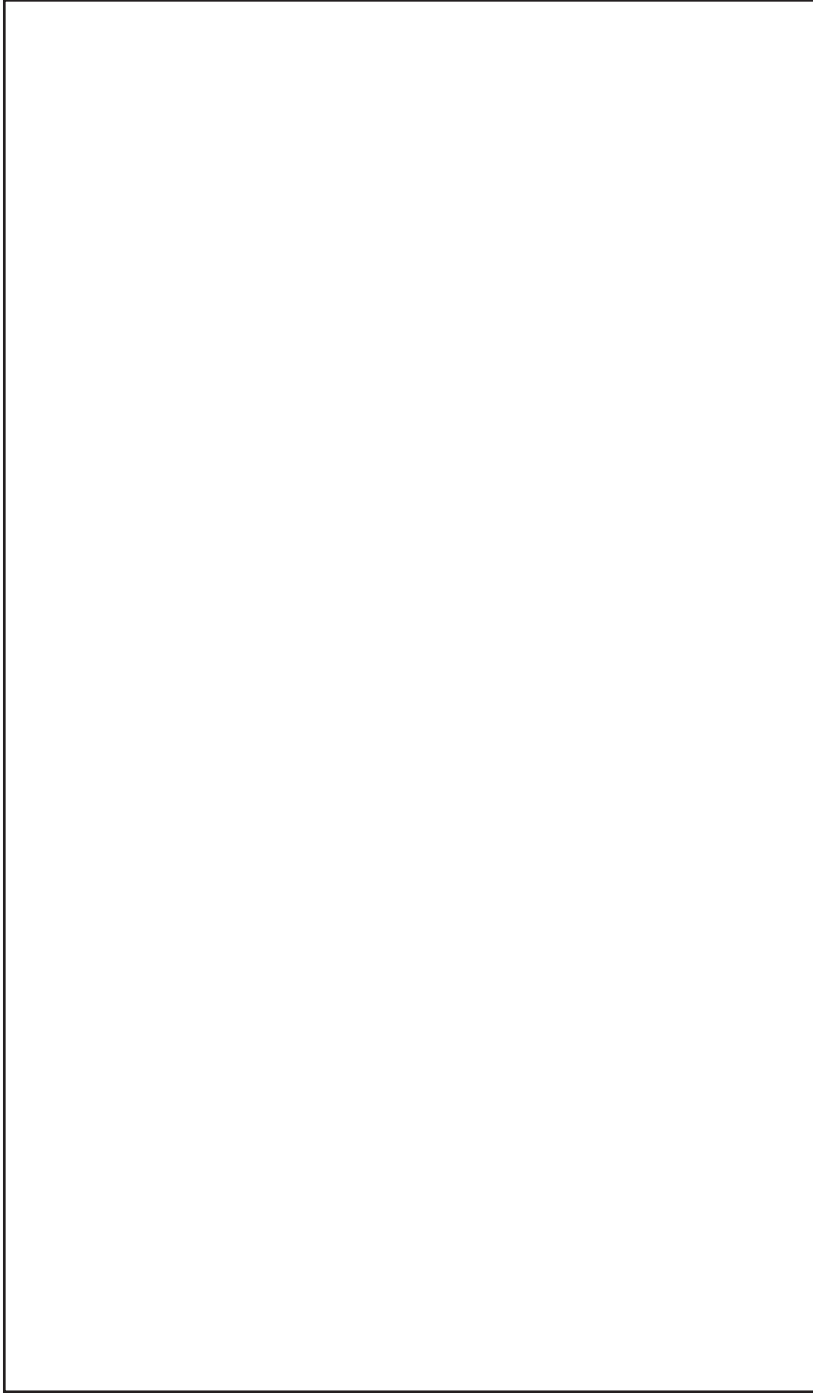

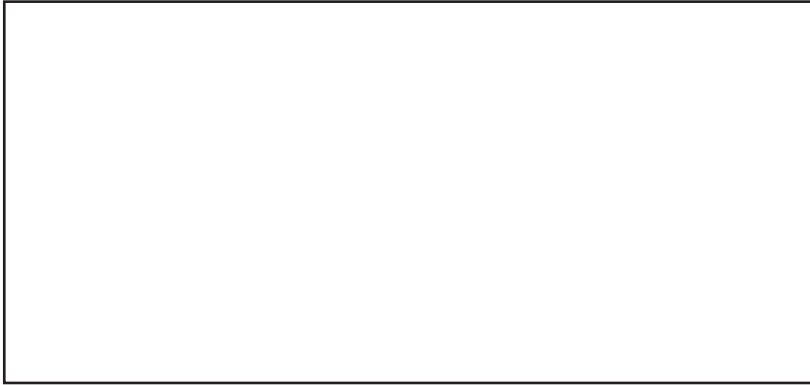

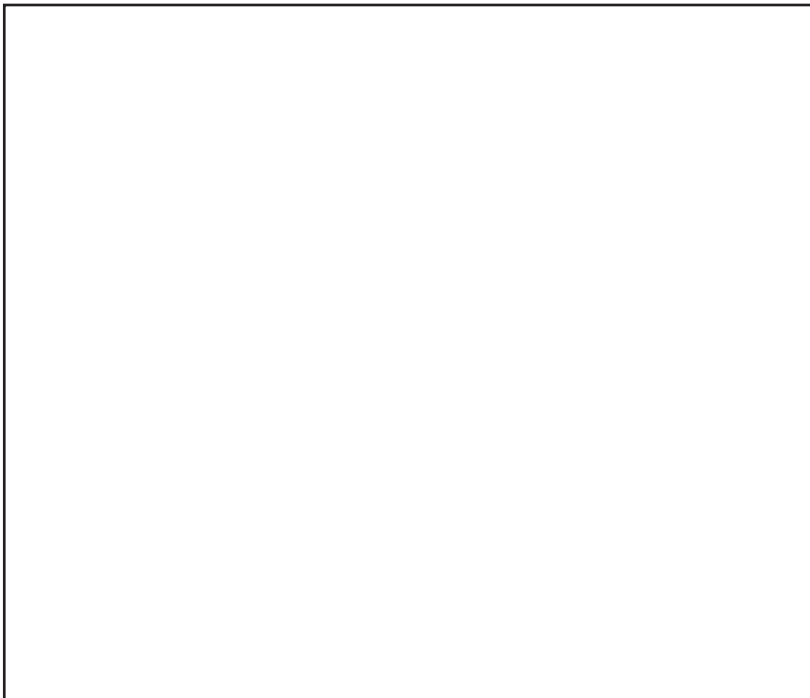


Full Page ad is
